Congratulations on being selected to join the **Jaguar Soccer Club** for the 2011/2012 **Seasonal Year!** Your skills and hard work have earned you a spot in one of the elite soccer clubs in Northeast Florida. Our coaches and Board of Directors (BOD) hope that this will be an enjoyable year for you and your family. As a part of the Registration Process, we want to ensure that you are fully aware and understand the commitments the **Jaguar Soccer Club** makes to you. As a result of your acceptance to the team, we also want you to be aware of our expectations of you and your obligations to the **Jaguar Soccer Club**.

Please **THOROUGHLY READ** the points below acknowledging your understanding of the mutual expectations between you and **Jaguar Soccer Club**, then please initial and date the bottom of pages 1-3 and sign and date page 4.

► It is our intent to honor the commitment to play with the **Jaguar Soccer Club** for the entire seasonal year. We understand that accepting the position offered and completing the registration documents obligates me to pay the full registration and uniform fees of \$900.00, regardless of whether we later decide to leave the **Jaguar Soccer Club** prior to the end of the seasonal year. (*Seasonal Year is defined as August 1, 2011 thru July 31, 2012*)

► We agree to make all installments toward fulfilling our financial obligation before or by the dates as follows, unless we apply to the BOD for and receive written approval for a modified payment structure: 1st installment of \$400.00 at acceptance to team following tryouts; 2nd installment of \$250.00 is due on or before July 10, 2011; final installment of \$250.00 is due on or before August 10, 2011.

► We understand that the **Jaguar Soccer Club** will provide training and coaching; opportunities to participate in league, tournament and cup games; and a uniform package consisting of: 2 jerseys, 2 shorts, 3 pairs of socks, two practice jerseys and 1 sports bag.

► We understand that practices are **MANDATORY**. The coaching staff follows a **NO PRACTICE-NO PLAY** policy, unless mitigating circumstances exist. In the event practice must be missed, notification must be given to the coach or his designee **PRIOR** to the practice session.

► We understand that since this is a premier competitive environment, there is **NO** guarantee of minimum playing time. We understand that attendance at all matches is **MANDATORY**. We also understand and agree to abide by the **Jaguar Soccer Club** policy of not allowing players to guest play with other teams or members of other teams to guest play with **Jaguar Soccer Club** teams, except with the express written approval of the team's coach or

designee. Approval will NOT be granted if all player's fees and financial obligations have not been fulfilled.

▶ Additionally, we understand that we will share in team expenses above and beyond the club registration fees noted above. These extra expenses may include but are not limited to: entry fees to league play outside of North Florida Youth Soccer League, tournament expenses, coaches fees/expenses related to tournaments, tournament referee fees, and travel costs associated with attending these events (even when we are unable to attend). The team may seek and receive donations or fund-raise to defray these expenses as well. We understand that all funds collected will be credited to my child's team account to be used for such team expenses. These funds remain with the **Jaguar Soccer Club** should the player decide to leave the club.

▶ Should the player wish to be released, to be transferred to another club, or to leave the team prior to the end of the seasonal year (for reasons other than for season ending injury/illness or a move out of district), the player/parents will be required to pay a \$150.00 transfer/release fee to **Jaguar Soccer Club**, in addition to fulfilling all financial obligations noted above, before the Change of Status is processed. Failure to do so, will result in placing the player in the conditional state pool and potentially placing the player "not in good standing" with FYSA.

▶ In the event the player sustains a serious injury that prevents the player from participating for ½ season or more, the player may request a partial refund of his/her registration fee. The Club will make the unilateral decision about whether to agree to the refund, and if so, how much. A player WILL NOT be entitled to any refund, if that player is/was retained on the active roster while injured.

▶ We understand that failure to comply with any of the afore-mentioned non-financial obligations to **Jaguar Soccer Club** could adversely affect the player's playing status with the Jaguar Soccer Club or any other league or state affiliated association. Minimally, the player may see reduced game play time. A coach may release a player from the team for 'failure to comply', provided the coach/Team VP has communicated this 'failure to abide' to the player and the player's parent(s) previous to the release.

▶ We understand that failure to fulfill our financial obligations to the Jaguar Soccer Club may result in the player being placed "Not in Good Standing" with the **Jaguar Soccer Club** and FYSA, which will result in the player's playing privileges being suspended until the obligations are fulfilled. This will also impact the player's ability to register with the Jaguar Soccer Club or any other affiliate next year.

▶ We have received and read the FYSA Code of Ethics as printed below, and agree to abide by the requirements. We will act in a manner of respect at all practices, games, travel, etc, and serve as role models to others to maintain the integrity of ourselves, our team, and all of **Jaguar Soccer Club**. Players will conduct themselves in accordance with **Jaguar Soccer Club**, FYSA, USYSA, USSF, and FIFA rules at all times, or will be subject to disciplinary action.

FYSA CODE OF ETHICS

PLAYERS:

- I will encourage good sportsmanship from fellow players, coaches, officials and parents at all times.
- I will always remember that soccer is an opportunity to learn and have fun.
- I deserve to play in an environment that is free of drugs, tobacco and alcohol: and expect everyone to refrain from their use at all soccer training and games.
- I will do the best I can each day, remembering that all players have talents and weaknesses the same as I do.
- I will treat my coaches, other players and coaches, game officials, other administrators, and fans with respect at all times; regardless of race, sex, creed or abilities and I will expect to be treated accordingly.
- I will concentrate on playing soccer, always giving my best effort.
- I will play by the rules at all times.
- I will at all times control my temper, resisting the temptation to retaliate.
- My conduct during competition towards play of the game and all officials shall be in accordance with appropriate behavior, and in accordance with FIFA'S Laws of The Game, and in adherence to FYSA rules.
- While traveling, I will conduct myself so as to be a credit to myself, and my team.
- A player cannot be cut from a team after he/she is registered to that team, unless he/she has exhibited conduct requiring dismissal, without prior consent from the BOD. If requested by the player and/or parent, a hearing must be held for any involuntary player release.
- **Alcohol, illegal drugs, tobacco products and unauthorized prescription drugs shall not be possessed, consumed or distributed before, during or after any game or at any time at the field and/or game complex.**

PARENTS/SPECTATORS:

- I will encourage good sportsmanship by demonstrating positive support for all players, coaches, game officials, and administrators at all times.
- I will place the emotional and physical well being of all players ahead of any personal desire to win.
- I will support the coaches, officials, and administrators working with my child, in order to encourage a positive and enjoyable experience for all.
- I will remember that the game is for the players, not for the adults.
- I will ask my child to treat other players, coaches, game officials, administrators, and fans with respect.
- I will always be positive.
- I will always allow the coach to be the only coach, by refraining from coaching from the sidelines.
- I will not enter into arguments with the other team's parents, players, or coaches.
- I will not enter the field of play for any reason during the game.
- I will not criticize game officials.

- **Alcohol, illegal drugs, tobacco products and unauthorized prescription drugs shall not be possessed, consumed or distributed before, during, after the game or at any other time at the field and/or game complex.**

Failure to comply with the FYSA Code of Ethics may result in the suspension of your privilege to participate in FYSA sanctioned events, for the following periods:

- 1st Offense: Suspension for a minimum thirty (30) days to a maximum of (5) years.
- 2nd offense: Suspension for a minimum of one (1) year to a maximum of ten (10) years.
- 3rd offense: Suspension for a minimum of five (5) years to a maximum of fifty (50) years.

FYSA ACKNOWLEDGMENT OF REGISTRATION

FYSA RECOMMENDS THAT PLAYERS NOT REGISTER TO A TEAM WHOSE AGE GROUP EXCEEDS THE PLAYERS NORMAL AGE.

INSURANCE NOTICE: All injuries must be reported within 90 days of the date of the injury. Benefits satisfied.

INFORMED CONSENT: I, the parent/guardian of the registrant, agree that we will abide by the rules of **Jaguar Soccer Club**, the state association (FYSA) and all its affiliated organizations. My/our child wishes to participate in soccer during the season of this registration. I/we realize risks are involved in my/our child's participation. I/we understand that the risk to my/our child includes full range of injuries from minor to severe, and the result could be death, paralysis, or other serious, permanent disability.
